# President's Message

# **Jackie Leonhard, GNMLS**

We are asking that if you are an MLS Participant Broker/Owner and you would be interested in serving on the GNMLS Board, please notify me by March 10. We are getting close to the launch of ShowingTime's MLS-wide release on March 3. Watch for training webinar opportunities coming the week of March 2. Initially, all offices will be active with ShowingTime, but you may choose to opt-out of using the system if you wish to. If your office already uses ShowingTime, this is going to be a great addition to your systems. If you are just an agent that likes to schedule showings with a click of a button, you will also see the benefit of the integrated system!

Remember to change your MLS system use to Xposure because 2020 will be the last year for Express and Interface. Now is the time to learn rather than your busiest season coming up. Note



that provided Microsoft changes don't break it, Interface desktop will remain available in 2021 at an individual fee of \$30.95 per month.

Lockboxes – on average fewer than half of the white BlueTooth (BT) lockboxes are being used on current active listings and overall inventory remains low. For these reasons, the MLS Board may postpone the purchase of additional lockboxes. Check your SentriLock account to verify that assigned lockboxes are on active rather than off-market listings. Boxes

on off-market listings should be removed promptly from the properties and changed to "Unassigned" when returned to your office. Remember as well to complete firmware updates on the Bluetooth (white) boxes for better battery life and functionality. If your office has < 50% of the Bluetooth boxes on active properties, the MLS office may ask you to return some to reassign to firms with higher lockbox usage rates. Should GNMLS buy more Bluetooth boxes, firms with > 50% active usage of their Bluetooth boxes will likely receive additional new lockboxes.

I just got back from CE in Las Vegas. Getting some warm sunshine on my face is making me want spring to come sooner than later. Let's hope for an early melt! Until then, I'll keep snowmobiling.



# MLS Memo

MLS rules say only the main house may be used for square footage, beds and baths. Guest guarters or other may be noted in the general remarks and there is a place to check Guest Cottage in the Exterior Features. This is also a national ANSI and AMS standard. An excerpt from ANSI Z765-2003 says, "Finished areas that are connected to the main body of the house by other finished areas such as hallways or stairways are included in the finished square footage of the floor that is at the same level. Finished areas that are not connected to the house in such a manner cannot be included in the finished square footage of any level."

Septic: "Conventional" means a nonmunicipal normal drain field in our MLS. "City Sewer" means it is connected to a municipal system. "Septic Installed" is used with a vacant lot to indicate the system has been put in.

Watch for new Waiver Forms and news for complying with NAR Policy 8.0 (MLS entry 1 day following public marketing).

MLS Tip: To leave the Autoload entry screen without saving changes just close the Tab for it.
