MLS Memo

The MLS Board wants to continue to emphasize the importance of properly measuring homes, as this is a critical factor considered by underwriters and necessary for appraisal information. Yes appraisers measure homes, but they don't measure all the comps that agents input which are needed to justify the price of the home. When the appraiser measures your listing, it needs to match what you put in the MLS. Please follow the basic American National Standards Institute (ANSI) standards as required by regulators. We hope to develop some further training, maybe a video with an appraiser. Begin by reviewing information from our website and these NAR tips. You may search YouTube for "ANSI Measuring" for some videos you might find helpful - look for those released in 2022 or later for current information. If you are an appraiser and see a discrepancy, the first step should be to contact the agent and help educate them so they can improve their professional representation.

MLS Tip: 2022 is done – remember to pull your Sales – Firm/Agent report in Xposure to save an archive of your yearly sales.

More of the same to start off 2023: low inventory and slower sales, albeit at +10-15% higher YOY medians for SFHs. WRA reports that statewide in January, YOY medians were up +8.5% (so we're a bit ahead), but the North region saw -43% in volume versus -34% statewide. That suggests we're still the hot market and while inventory is low everywhere, WRA reports rural areas are in better shape at 2.6MOI versus 1.9MOI statewide. To summarize, still plenty of folks hoping to move Up North, but not so many are eager to move away. Guess our secret's out!
