
NWAR Scholarship - Deadline 4/1

Time is almost up for **NWAR Family** Scholarship applications that are due by April 1st.



MLS Memo



Advertising listings: Before posting anything on social media about a listing, please take note that by Wis. Stat. § 452.136 you need a valid listing contract if you advertise a property for sale OR you need the listing broker's permission. You must always name the brokerage who has the contract and the name needs to be "clear and conspicuous" in the advertisement. Also note this statute requires you to advertise a price in the ad that has been agreed to by the seller.

As we move deeper into the final year of accessing lockboxes with cards, please become more familiar with the features of the SentriKey app. Learn how to create a schedule for showing agents so they will have correct codes when they arrive at old boxes.

MLS Tip: Please put a priority on using the newer white BLE bluetooth boxes on listings instead of the older NXT blue boxes which are more likely to have dead batteries or other problems.

April is Fair Housing Month

April is Fair Housing Month, and WRA just released episode 11 of *Legal Update Live* titled "Fair Housing and Fairhaven".



In this edition, WRA Attorney Debbi Conrad is joined by NAR Fair Housing Representative Alexia Smokler who recapped a 3-year Newsday study on Long Island which found that 40% of the time, agents treated nonwhite testers differently from white testers. Upon learning of this eye-opening study, NAR created the "Fairhaven" free online simulation wherein REALTORS can test your compliance with fair housing principles.

As the adage goes, "Buy land - they're not making more" - notwithstanding some palmshaped islands on the Dubai coast). Word seems to be spreading that the Northwoods has land to spare, since it's selling at more than double the pace of a year ago. SFD sales aren't far off that pace, and the gap is likely a symptom of our historically low SFD inventory. Lon noted that we actually have more homes with pending offers at present than without - WOW!
