

## NAR Personal Conduct Policy Changes

At the NAR Convention earlier this month, the Board of Directors voted to extend Article 10 of the Code of Ethics to apply to every action a REALTOR takes - whether professional or personal in nature. Article 10 states it is a violation of the Code of Ethics to use harassing or hate speech toward any protected classes (race, color, religion, sex, handicap, familial status, national origin, sexual orientation, gender identity). Going forward, it is important to understand that any speech - even if outside the context of your REALTOR career - may be reported to the Professional Standards Committee as a possible violation of Article 10 if it disparages a protected class.

While some argue that this infringes upon free speech, First Amendment protections do not extend to a private membership organization. The social tensions following the George Floyd and other incidents led some to share opinions online that were arguably (or obviously) hate speech, and NAR's ruling followed a rash of complaints about some REALTORS posting disparaging comments online. Please make sure that at *all* times starting *now*, you are upholding the REALTOR Code of Ethics and Fair Housing principles. There is no time like the present for REALTORS to uphold our commitment to professionalism and equal opportunity.

## NAR-DOJ Agreement Re: MLS Rules

NAR and the US Dept. of Justice just this week announced a DOJ review that led to a settlement agreement regarding a handful of MLS policy statements. The settlement has not yet been finalized, but they expect to do so within 45 days followed by approval by the NAR Board of Directors. To summarize, here are the MLS rule changes that NAR expects to implement:

- The amount of compensation being offered to buyers' agents for each listing will be made publicly available
- Reaffirm that MLSs and brokerages must provide consumers all properties that fit their criteria regardless of the compensation offered or name of the listing brokerage
- Clarify that buyer's agents cannot represent that their services are free to clients
- Require that, with seller's prior approval, any licensed real estate agent may access the lockboxes of MLS-listed properties even if the agent does not subscribe to the MLS

Because this stemmed from a confidential DOJ inquiry, it was inappropriate for NAR to share this until the findings became apparent. NAR does not agree with the DOJ's characterization of their MLS policies and admits no wrongdoing, liability or truth to these allegations. Nonetheless, NAR has agreed to make the above changes to address the questions raised by the DOJ. If you have concerns about how these potential rule changes may impact your business, please forward them to the GNMLS office or leadership for consideration at an upcoming GNMLS Board meeting.

## **MLS Memo**

In the past, our listing entry page has included a field designating if the listing should be sent to realtor.com or not. Since we did not have a place to designate withholding the listing from the internet displays, the only way to comply with a seller's desire to keep the information off the internet was to not enter it in the MLS. New NAR rules require listings to be entered into MLS.

In order to allow sellers to refrain from internet advertising and still meet the requirement for MLS entry, we have repurposed the old entry option so it now designates whether the listing should be displayed on the internet or not. Please be aware that if your seller does not wish to include internet advertising, then you should select No for internet display and the listing will not appear on upnorthmls.com or feeds coming from Trestle. RETS or IDX feeds from RealtyServer may include the listing, but it is flagged so your website should not be displaying it to the public. Happy Thanksgiving to everyone as we look forward to 2021.

MLS Tip: In a CMA if the address is not found you can type it, then click outside the street field.

Volumes for off/on water homes are up 18.4% and 30.7% respectively on median gains of 4.0% and 16.3%. As impressive as that is, land is even stronger at 41% and 74.7% volume gains for off/on water and 10% median gains in both cases.

The only headwind we face is supply since it seems everyone is seeking sanctuary in the Northwoods. Good news on the vaccine front may slow the urban exodus though, and a reversion to mean is inevitable. Make hay while the sun shines, but we should take care to remember the lessons learned circa 2007.
