

Real Estate License & Membership Renewals

NWAR renewal statements were mailed out recently and we are pleased to report that NWAR and WRA dues are unchanged for the year ahead, while NAR had a modest \$10 increase to their consumer advertising assessment. Please renew your membership by November 30th and note the yellow insert (see pg 2) about a special RPAC incentive this year. If you have any changes to your contact info, membership status (eg: switching NWAR from secondary to primary local board) or do not receive your statement by 9/30, please contact Matt for prompt assistance.

Even-numbered years are also real estate (and business entity) license renewal years, so make sure to complete 18 hours of CE and renew your real estate (and entity if you have one) license before they expire on 12/14/22. You can complete CE online through WRA or attend video CE at NWAR starting 10/27 (see pg 3), and the DSPS license renewal portal is not open presently for real estate licensees but should be by early November - add a note to your calendar!


Thank you for the opportunity to serve as your MLS President. It was an honor. My final "thank you" is to the Bears for helping us right the ship, as is tradition.

Budget Vote Results

THANK YOU for keeping NWAR & GNMLS in business another year by voting resoundingly to approve our new budgets!



GNMLS has had a banner year with several new firms and agents joining, which enabled the board to give generously to local charities in 2022. By a 97% favorable vote of 67-2 on 9/19, GNMLS Participants approved the 2022-23 GNMLS Budget which includes \$10k in community investments and \$15k in advertising.

The NWAR Budget was also approved Sept 21st by a 95% majority vote of 170-9. The new NWAR budget includes \$15k+ towards charities, scholarships, advertising and Member benefits like educational incentives and Tech Helpline in the year ahead. We appreciate your vote of confidence and remain committed to managing NWAR and GNMLS with fiscal prudence and good governance!

campaign off on a high note once again this year, but we are still just short of halfway to our goal for the year. LEALTONS POLITICAL ACTION COMMITTEE

It is therefore critical to keep our streak intact that you include the optional RPAC investment with your timely dues renewal by

November 30th. While the recommended investment is \$50, we appreciate whatever amount you can spare for RPAC when
renewing. Note also that WRA has a unique Direct Giver program (minimum \$100) which will allow you to control which
candidate(s) receive your investment - just include a personal check for \$100+ payable to "WRA Direct Giver" when renewing,
and you can then instruct WRA (or Matt) on what amount(s) you wish to distribute to candidate(s) of your choosing!

The yellow insert with your 2023 NWAR renewal statements also notes a special incentive: if at least 150 Members include \$50 + to RPAC/DG when renewing by 11/30, we will make a \$500 donation to Tri-County Council on Domestic Violence and Sexual Assault (TCCDVSA) from our remaining RPAC promo budget. If 200+ Members give \$50+ by 11/30, we'll increase that to \$700. We will also send TCCDVSA a list of all NWAR Members whose support for RPAC enabled us to make this charitable donation. Lastly, we will once again recognize all RPAC/DG donors who give \$100+ at our Christmas Party (with a sweet treat) as well as in our January newsletter, and investors of \$500+ will include a photo while \$1000+ givers will also be recognized on the NWAR website in early 2023. THANK YOU for your support for RPAC so we can hopefully reach our goal once again in 2022!
